- Calculating genetic gain among bovines
- Collecting and publishing production and breeding records of registered animals
- Creating awareness among farmers and improving their income

To facilitate his engagement as an Honorary Animal Welfare Representative, I kindly request your assistance in ensuring that he is integrated into the operations of the Block Government Veterinary Hospital and provided with any necessary orientation or training.
