Adoption of Revised ABC Module as Standard Operating Procedure (SOP) -

regarding.

Sir/Madam,

With reference to the subject cited above, it is submitted that the Animal Welfare Board of India (AWBI) had submitted a revised ABC Module on 14.09.2016 before the Hon'ble Supreme Court in SLP (C) No. 691 of 2009, in compliance with the Court's order dated 20.07.2016. A copy of the same was circulated to all concerned parties.

- 2. This revised module outlined, in detail, the infrastructure requirements for Animal Birth Control (ABC) Centres, humane methods for dog catching and release, surgical procedures, minimum equipment required for surgeries, regulation of dog breeding and pet shops, transportation of dogs, and maintenance of kennels, among other key components. It was developed as a comprehensive technical document to guide proper implementation of the ABC Programme in accordance with the ABC Rules, 2001.
- 3. Following the notification of the Animal Birth Control Rules, 2023 by the Central Government, the earlier module was comprehensively reviewed and updated. The revised ABC Module was published on 27.02.2025 to reflect the latest regulatory requirements and best practices. The Module is available at:

- 4. In order to ensure uniformity, transparency, accountability, and efficiency in the execution of the ABC Programme, it is hereby requested that the revised ABC Module be adopted as the Standard Operating Procedure (SOP) by all implementing departments and agencies.
- 5. All concerned authorities, including State Animal Welfare Boards, Urban Local Bodies (ULBs) such as Municipal Corporations, Municipal Councils, Nagar Panchayats, and other implementing agencies at the local level, shall circulate and implement the SOP with immediate effect.
